In addition, submit the following with each bid: Non-Collusion Affidavit, and Qualification Questionnaire.

Notice is given that the Project for which construction bids are being solicited hereby is a Project constituting public works and is subject to applicable provisions of the Pennsylvania Prevailing Wage Act, Act of August 15, 1961, P.L. 987, as amended and supplemented, and appropriate prevailing minimum wage rates as promulgated under provisions of said Act must be paid by Contractors in connection with performance of the necessary work.

Corporations seeking to bid and organized under the laws of a state other than the Commonwealth of Pennsylvania must secure the appropriate certificates and authorizations permitting them to conduct business within the Commonwealth.

Owner reserves the right to accept or reject any or all Bids or part thereof or items therein and to waive any informality in the bidding.
