 difficulties the same opportunities as other parents. These opportunities may be structured, adapted, or

- Pleasant Hills Middle School will provide information to parents about the Parent Resource Center.

Pleasant Hills Middle School will coordinate Title I parent involvement activities with other parental involvement activities.
