## <u>Changes to Dismissal Procedures at Gill Hall Elementary</u> Effective Monday, March 5, 2018

The goal of the changes is to minimize the amount of people that are accessing the building on a daily basis, increasing the security of the building. Therefore, *no parents/guardians will be permitted into the building during arrival and dismissal procedures*, allowing all exterior doorways to be locked at all times unless under supervision.

## **NEW DISMISSAL Procedures:**

- All **Car Riders** will be dismissed to the gymnasium lobby at 3:10, where a staff member will be on dismissal duty. Students will then be dismissed to their parents/guardians outside of the exterior gymnasium entrance.
- Parents/Guardians will no longer be able to access the building to pick up their students during this time. Parents/Guardians must wait outside of the gymnasium entrance and the staff member will release each individual student to his/her parent/guardian. Bus Dismissal procedures will remain the same.
- **A.M. Kindergarten**: Parents picking up students from morning kindergarten must wait outside of the front entrance. Students will be dismissed to you at 11:15.
- Please send a note to school with your child if they are going to be a car rider that day. We will add them to the list of our daily car riders. DO NOT EMAIL the teacher during the course of the day. We ask that all requests for pick-ups are made prior to 12:00.
- Please do not park around the circle. Parking is available in the lower lot.
