2011-2012 SunTrust Off To College Scholarship Sweepstakes Official Rules

- To Enter:** The Off To College Scholarship Sweepstakes begins on 09/16/11 and ends 5/11/12, "Sweepstakes Period"). To enter, student must complete an online entry form by accessing the SunTrust Education Loans Web site page (offtocollege.info). Entries are limited to one per person during each drawing period. Entries must be received by 05/11/12 for final drawing at 5 p.m. ET on that date. No mechanical reproductions permitted. Entries will be based on date of entry for the applicable drawing and are limited to one per person, per drawing period. If a student does not win, they may enter the sweepstakes again after each drawing. Scholarship entries not selected on each designated drawing date will not automatically be included in subsequent scholarship drawings, i.e. entries do not carry over to the next drawing.
